- 2. FIG Course. A letter on the matter from Frank Cumiskey to Jon Culbertson was discussed. There will be an Intercontinental Course offered in Paris from Sept. 3 thru 7. USGF is entitled to send 3 men and 3 women but they must be currently holding a valid FIG card. USGF is willing to pay the cost of one judge totally and half of the expenses for two others.
