Notes for Olympic Trials:

- Above are the 6 judge panels. Basic panel of 4 stays consistent for Las Vegas, Hartford, and St. Louis plus additional two E judges for Olympic Trials in St. Louis.
- Result: D judges evaluate every athlete one time (18 routines). E judges evaluate every athlete twice (over 2 events, 36 routines each day)
- Thursday competition starts on FX, SR, & PB. Saturday competition starts on PH, VT, & HB. Every group moves in Olympic order from starting event.
